## **Teacher's Forum**

Beginning in 2006, Wayne P. Last year the office awarded forty five \$100 scholarships. Teachers of grades K-12 are encouraged to apply.

In selecting the recipients, we will consider the proposed use of the funds and the neediness of the request. For example, proposals may be made for the purchase of a cranial skeleton for a science class or books for a first grade reading program.

Applications must be received by September 30<sup>th</sup>. Just complete the application and return it to our office by the deadline. Funds will be awarded by October 31st.

A special thanks from all of us at Bowling & Dunn Family Dentistry. It is our hope that the **Teachers' Scholarship Fund** will provide materials that will benefit teachers and students for years to come.
